**Purpose.** The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

**Applicability.** The Form HUD-50075-HCV is to be completed annually by **HCV-Only PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, Small PHA, or Qualified PHA do not need to submit this form. Where applicable, separate Annual PHA Plan forms are available for each of these types of PHAs.

### Definitions.

- (1) *High-Performer PHA* A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on <u>both</u> the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) Small PHA A PHA that is not designated as PHAS or SEMAP troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) Housing Choice Voucher (HCV) Only PHA A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) Standard PHA A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS and SEMAP assessments.
- (5) Troubled PHA A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) Qualified PHA A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

To provide decent and affordable housing, promote self-sufficiency, homeownership, and ensure equal opportunity to very low and extremely lowincome families in Jefferson and Franklin County Missouri.

# Goal: Increase the availability of safe, decent, and affordable housing

Objectives: 1. Maximize utilization of the Housing Assistance funds available in order to provide housing assistance to as many families as possible.

- 2. Accurately calculate the family's portion of the rent so that their portion of the rent is affordable.
- 3. Maintain high scores in voucher management as reflected in SEMAP rating.
- 4. Ensure that Housing Quality inspections are conducted annually, and any deficiencies are corrected in a timely manner.
- 5. Apply for any additional rental vouchers when available and approval is possible
- 6. Increase voucher payment standard when necessary
- 7. Maintain the homeownership program
- 8. Support developer's new construction and rehabilitation of affordable housing for lowincome, elderly, and disabled households and for accessible units through state tax credit funding.
- 9. Support HUD's initiative to end homelessness

- Objective: 1. Maintain at least 75 families on the FSS program
  - 2. Increase the number of successful FSS contract completions
  - 3. Maintain the homeownership program and increase the number of homeowners.

### Goal: Ensure equal opportunity for all participants and affirmatively further fair housing

- Objective: 1. Provide annual fair housing training to staff
  - 2. Provide families with information on fair housing at the briefing and when families move This information is also provided with each FSS enrollment.
  - 3. Landlords are encouraged to participate in providing rental units in low-poverty areas and families are encouraged to locate housing in low-poverty areas. This information is included. in the briefing and Request for Tenancy Approval packets.
  - 4. Any discrimination complaint is addressed timely and completely.
  - 5. Owners sign a Housing Assistance Contract which includes a provision for non-discrimination.

### Progress:

### Goal: Increase the availability of safe, decent, and affordable housing

- 1) In the last year, Franklin County PHA (FCPHA) was able to utilize 76% of our available housing units while utilizing 100% of our housing assistance funds. In the same time period, 194 new families began receiving housing assistance. This includes families off our waiting list and those
- 2) In the last year, 91% of the new admissions had income at or below 30% of AMI (extremely low-income families).
- 3) FCPHA achieved a High Performer rating from HUD through the Section 8 Management Assessment Program (SEMAP) self-certification reporting in the last reporting period. This assessment scores the PHA under 14 performance indicators such as the accuracy of the family's rent calculation and that HQS inspections were conducted annually with deficiencies corrected in a timely manner.
- 4) FCPHA is awaiting the award of five additional VASH vouchers. These vouchers come to us as a referral from the Veteran's Administration to house homeless veterans.
- 5) Payment Standards were increased in the last year to enable our families greater access to the rental market.
- 6) FCPHA has maintained the homeownership program. There are currently eleven families receiving assistance with their mortgages.
- 7) FCPHA supports developer's new construction and rehabilitation of affordable housing for low-income households and for accessible units by providing the developers with a letter of support, partnering with, or providing other sources of information on the need in the community as requested. FCPHA is working directly with two developers. One project was approved, and we are providing referrals to house eligible families.
- 8) FCPHA supports HUD's initiative to end homelessness by implementing the homeless preference.
- 9) FCPHA has hired a landlord liaison to help recruit new landlords and maintain current ones.

A PHA will be considered in compliance with the certification requirement to affirmatively further fair housing if the PHA fulfills the requirements of §§ 903.7(o)(1) and 903.15(d) and: (i) examines its programs or proposed programs; (ii) identifies any fair housing issues and contributing factors within those programs, in accordance with 24 CFR 5.154; or 24 CFR 5.160(a)(3) as applicable (iii) specifies actions and strategies designed to address contributing factors, related fair housing issues, and goals in the applicable Assessment of Fair Housing consistent with 24 CFR 5.154 in a reasonable manner in view of the resources available; (iv) works with jurisdictions to implement any of the jurisdiction's initiatives to affirmatively further fair housing that require the PHA's involvement; (v) operates programs in a manner consistent with any applicable consolidated plan under 24 CFR part 91, and with any order or agreement, to comply with the authorities specified in paragraph (o)(1) of this section; (vi) complies with any contribution or consultation requirement with respect to any applicable AFH, in accordance with 24 CFR 5.150 through 5.180; (vii) maintains records reflecting these analyses, actions, and the results of these actions; and (viii) takes steps acceptable to HUD to remedy known fair housing or civil rights violations. impediments to fair housing choice within those programs; addresses those impediments in a reasonable fashion in view of the resources available; works with the local jurisdiction to implement any of the jurisdiction's initiatives to affirmatively further fair housing; and assures that the annual plan is consistent with any applicable Consolidated Plan for its jurisdiction. (24 CFR §903.7(o)).
  - C.4 Challenged Elements. If any element of the Annual PHA Plan or 5-Year PHA Plan is challenged, a PHA must include such information as an attachment to the Annual PHA Plan or 5-Year PHA Plan with a description of any challenges to Plan elements, the source of the challenge, and the PHA's response to the public.

### D. Affirmatively Furthering Fair Housing (AFFH).

**D.1** Affirmatively Furthering Fair Housing. The PHA will use the answer blocks in item D.1 to provide a statement of its strategies and actions to implement each fair housing goal outlined in its accepted Assessment of Fair Housing (AFH) consistent with 24 CFR § 5.154(d)(5) that states, in relevant part: "To implement goals and priorities in an AFH, strategies and actions shall be included in program participants' ... PHA Plans (including any plans incorporated therein) .... Strategies and actions must affirmatively further fair housing ...." Use the chart provided to specify each fair housing goal from the PHA's AFH for which the PHA is the responsible program participant – whether the AFH was prepared solely by the PHA, jointly with one or more other PHAs, or in collaboration with a state or local jurisdiction – and specify the fair housing strategies and actions to be implemented by the PHA during the period covered by this PHA Plan. If there are more than three fair housing goals, add answer blocks as necessary.

Until such time as the PHA is required to submit an AFH, the PHA will not have to complete section D., nevertheless, the PHA will address its obligation to affirmatively further fair housing in part by fulfilling the requirements at 24 CFR 903.7(o)(3) enacted prior to August 17, 2015, which means that it examines its own programs or proposed programs; identifies any impediments to fair housing choice within those programs; addresses those impediments in a reasonable fashion in view of the resources available; works with local jurisdictions to implement any of the jurisdiction's initiatives to affirmatively further fair housing that require the PHA's involvement; and maintain records reflecting these analyses and actions. Furthermore, under Section 5A(d)(15) of the U.S. Housing Act of 1937, as amended, a PHA must submit a civil rights certification with its Annual PHA Plan, which is described at 24 CFR 903.7(o)(1) except for qualified PHAs who submit the Form HUD-50077-CR as a standalone document.

This information collection is authorized by Section 511 of the Quality Housing and Work Responsibility Act, which added a new section 5A to the U.S. Housing Act of 1937, as amended, which introduced the Annual PHA Plan. The Annual PHA Plan provides a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, and informs HUD, families served by the PHA, and members of the public for serving the needs of low- income, very low- income, and extremely low- income families.

Public reporting burden for this information collection is estimated to average 6.02 hour per response, including the time for reviewing instructions, searching existing data sources, gathering and maintaining the data needed, and completing and reviewing the collection of information. HUD may not collect this information, and respondents are not required to complete this form, unless it displays a currently valid OMB Control Number.
